The Academy offers quality flying training in CPL Course for issue of CPL with Instrument Rating (IR).
2. Shortlisted candidates will be considered for admission based on the final merit list in the batch starting tentatively from October / November 2024.

Should have passed with 50% marks in 12 th Std. or equivalent with 55% aggregate marks in Maths, Physics & English.	Should have passed with 45% marks in 12 th Std. or equivalent with 50% aggregate marks in Maths, Physics & English.

Note :- In case SC/ST candidates do not qualify for admission to the reserved seats, such seats shall be filled up with candidates from the General Category.

4. **Medical :**
Selected candidates may join with Class II Medical. However, they will have to clear and submit Class – I Medical Fitness Certificate subsequently. Please check DGCA website for List of approved Centres/Doctors for Class-I & II Medical test.
5. The selected trainees have to undergo examination of consumption of Psychoactive substance and has to produce a negative report as per CAR Sec 5 Series F Part V of DGCA.
6. **Training fee :**
The total training fee for CPL with IR incl. Ground School on single engine is Rs35,35,000/-

The same is to be paid in Five installments as shown below: -
1st Installment Rs. 12,35,000/- at the time of joining
2nd Installment Rs. 6,00,000/- on completion of 40 hrs. of flying
3rd Installment Rs. 6,00,000/- on completion of 80hrs. of flying
4th Installment Rs. 6,00,000/- on completion of 120 hrs. of flying
5th Installment Rs. 5,00,000/- on completion of 160hrs. of flying
(Rs. 6,00,000/- minus Rs.1,00,000/- commitment fees)
7. If the trainees wish to do CPL with Multi Engine endorsement on Piper Seneca PA 34 they have to undergo 15 hours of flying training on multi engine aircraft of the Academy @ Rs. 45,000/- per hour. Total flying will be 185 hours on Single Engine + 15 hours on Multi Engine in such cases.
8. Taxes, if any, applicable on the Training Fee will have to be paid in due course. Academy reserves its right to revise the fee from time to time which will be binding on the trainees. Advance payment of installments in time is, mandatory for commencement/continuation/resumption of flying.
9. **Selection :** Selection process will be based on either (a) and (b) below or (b) alone, as the case may be depending on the number of applications received.
